



AFFIDAVIT

I, **Lukuman Moosari Kandi**, aged 54 years, residing at Riyadh, Kingdom of Saudi Arabia, presently serving as the Manager of Alif International School, Riyadh, KSA (Affiliation No. 5730040), do hereby solemnly affirm and sincerely state as follows:

1. That Alif International School, Riyadh, is run by its School Managing Committee (SMC) as an Indian community school under the supervision of the Ministry of Education, Kingdom of Saudi Arabia.
2. That Alif International School, Riyadh, is of a Non-Proprietary Character.
3. That the school is being operated as a community service and not as a business, and that commercialization does not take place in the school in any manner whatsoever.
4. That no part of the income from the institution is being, or will be, diverted to any individual in the Trust/Society/Company/School Management Committee or to any other person/entity. The savings, if any, after meeting recurring and non-recurring expenditure and contributions to developmental, depreciation, and contingency funds, will be utilized solely for promoting the school and extending the cause of education within the same school.

That the Principal and I, as Manager/Correspondent of the school, have individually reviewed the provisions contained in the CBSE Affiliation and Examination Bye-Laws, as well as circulars issued by the Board from time to time. The school undertakes to abide by these provisions, directions issued by the Board, and the laws of the land.
7. That the school will ensure compliance with all statutory requirements, including the Employees' Provident Fund (EPF), Employees' State Insurance (ESI), and applicable Labour Laws, with respect to the school and its staff.
8. That the school will ensure that Building Safety, Fire Safety, Water Safety, and Health and Hygiene certificates are issued or renewed by the concerned municipal or state authorities as per the prescribed terms.
9. That the school will ensure that all required infrastructure is available before commencing classes.
10. That the school will ensure that a sufficient number of qualified teachers, as per the provisions of the CBSE Affiliation Bye-Laws, are employed before starting classes.
11. That the school will adhere to the provisions related to fees as outlined in the CBSE Affiliation Bye-Laws and will disclose fee details to students and parents annually before the start of the session, without resorting to any hidden charges under various fee heads.
12. That the school will not coerce any student or parent to purchase books, stationery, or uniforms from any particular shop.
13. That the school shall strive to make continuous efforts toward the conservation of the environment.
